

## Questions and answers about the application for sponsorship from Scania in Södertälje

### Who can apply for sponsorship?

- Associations/clubs/organisations in Södertälje municipality that are not currently sponsored by Scania or by other Scania-owned subsidiaries can apply for a short term award up to 20 000 SEK.
- The application should be permitted by the organisation and the person submitting the application should not be a Scania employee. Any potential conflicts of interest, such as family and personal relationships and personal financial interests, must be described according to "Scania Group Policy 46 - Conflict of Interest".

### Who can't apply for sponsorship?

- Individuals can't apply for sponsorship.
- Associations/clubs/organisations that are currently sponsored by Scania.
- Associations/clubs/organisations that received sponsoring current year.

### How do you apply and what must the application contain?

- Complete the web application. Please note that no changes can be made after the application has been submitted.
- Most of the information is mandatory in the web application. You can choose if you want to complete the form in English or Swedish.

### What can you get sponsorship for?

- Initiatives and activities that strengthen and contribute to a more meaningful leisure time for the residents of Södertälje municipality, with a focus on children and young people.
- Permissible areas of support are education, science and research, culture, charitable causes, sustainability, the heavy truck industry and sports. Please note that even in areas eligible for support sponsoring measures are not admissible if they pertain categories stated in the Scania Group Policy 5 Handling Donations and Sponsoring Measures.
- Sponsorship can only cover future activities and cannot be used retroactively.

### What can't you get sponsorship for?

- The sponsorship is linked to the current application and cannot be given away or shared with anyone else.
- Elite initiatives.

## **When can you apply and when will you receive a response to your application?**

- The application period is open until 19 October 2025.
- Applications submitted before 19 May 2025 will be evaluated and answered by us no later than 14 July 2025.
- Applications submitted between 20 May 2025 and 19 October 2025 will be evaluated and answered by us no later than 18 December 2025.

## **Can you make changes in your application after you have submitted it?**

- No, it is not possible to make changes after submitting the application. But if you need to make any adjustments, contact [sponsoring@scania.com](mailto:sponsoring@scania.com). Your application will be removed and you can then submit a new application.

## **How is the selection done and who decides on sponsoring contributions?**

- It is Scania's decision forum for Sponsoring and Community Engagement that makes decisions about who receives sponsoring contributions.
- Please note that according to "Scania Group Policy 46 - Conflict of Interest" Scania employees with involvement in the organisation applying for sponsorship may not be involved in the decision-making process, either from the organisation's side or from Scania's side.
- Check of recipient, Due Diligence, will be carried out by Scania and must be approved before a sponsoring contribution can be considered.

## **How many associations/clubs/organisations will receive sponsoring?**

- Scope and number will look different depending on the number of applicants and the type of applications. Scania reserves the exclusive right to decide who receives the contributions.

## **How large sponsorship contribution can one apply for?**

- You can apply for amounts from 1,000 SEK to 20,000 SEK.

## **What counter-performances will Scania demand?**

- Agreement on expected counter-performance from each party takes place in dialogue and is regulated in a written agreement drawn up by Scania.

## **How is the sponsoring contribution paid?**

- The recipient sends an invoice to Scania for the amount. The amount will be paid within 60 days.
