MODERN SLAVERY AND HUMAN TRAFFICKING STATEMENT FOR THE FINANCIAL YEAR [2023-2024]

INTRODUCTION

This modern slavery and human trafficking statement is made on behalf of West Pennine Trucks Ltd pursuant to section 54(1) Modern Slavery Act 2015.

OUR BUSINESS

West Pennine Trucks is one of six independent dealers' groups across the Scania network and has held a Scania franchise since 1986. It is the North West's largest privately owned, authorised Scania dealer group and covers the industrial areas of Greater Manchester down into the more rural counties of Cheshire, Staffordshire, Shropshire, and mid-Wales. The West Pennine Trucks team provide the complete sales and aftersales support package and work side by side with some of the most recognisable brands in the UK. There are six depots and two' VMU's across the Northwest, as well as a head office located in Middleton, Greater Manchester. The company employs around 220 people across the UK and operates solely in the United Kingdom.

West Pennine Trucks Limited is part of Ballyvesey Holdings Limited, a privately owned parent company with a wide range of trading subsidiaries, established in 1970.

OUR SUPPLY CHAINS

West Pennine Trucks has strong and lasting relationships with all of our suppliers, and all of our suppliers must accept and comply with our Supplier Code of Conduct. West Pennine Trucks communicates this code of conduct with suppliers, as well as publicising this on our website. West Pennine Trucks expects all suppliers to have a zero-tolerance policy on modern slavery, human trafficking and child or forced labour in relation to its employees and suppliers.

Whistleblowing Policy

Supplier Code of Conduct

West Pennine Trucks is committed to ensuring that its suppliers adhere to the highest standards of ethics. Our Supplier Code of Conduct sets out the ethical obligations and working conditions we expect from all our suppliers. This code is shared with all suppliers and publicised on our website.

Recruitment Policy

The organisation specifically uses one recruitment agency as directed by our parent company. As this approved agency is also part of our wider group company they adhere to the same levels of conduct and ethics demonstrated by all companies within the group. If West Pennine Trucks engage with any other employment agencies, their compliance with our code of conduct is required and full checks into their practices will be undertaken by Senior Management.

DUE DILIGENCE PROCESSES AND RISK MANAGEMENT

The organisation undertakes due diligence when considering taking on new suppliers, and routinely reviews existing suppliers in line with the standards defined by our code of conduct.

West Pennine may at any time review and/or request supplier self-assessments and/or perform on site audits at the supplier’s locations, usually preannounced.

Any concerns regarding incidents of modern slavery or human trafficking can be reported to any of our Senior Managers, and any concerns will be thoroughly investigated.

TRAINING

West Pennine Trucks has introduced mandatory training for all Management and Human resources staff in line with Stronger Together.

Understand what modern slavery, forced labour and hidden labour exploitation is


Know how to recognise the signs that someone may be being exploited and how to respond
